

## ***CORPORATE CLIENT SERVICES SAMPLE AGREEMENT***

inLOBBY GmbH (hereinafter referred to as "Company"), registered by the address Elbinger Str. 20, 41844 Wegberg, Germany, on behalf of its General Director, Stepan Adamyan, acting on the basis of the Charter, from one side and \_\_\_\_\_ (hereinafter referred to as "Client") on behalf of \_\_\_\_\_, acting on the basis \_\_\_\_\_ from another side (hereinafter individually referred to as "Party," collectively as "Parties") have signed the present agreement (hereinafter referred to as "Agreement") hereto as follows:

### **1. Subject of the Agreement**

Under the present Agreement the Company provides the Client Hotel accommodation (conference halls, banquet halls) searching, selection and reservation services through inLOBBY.com platform.

### **2. Definitions**

- "Hotel (-s)" means hotels which cooperate with the Company and are available on the website (-s) of inLOBBY.com.
- "inLOBBY.com" means all websites owned by Company and operated from its domains.
- "Information" means information of the Hotels which are included in inLOBBY.com and are provided to the Client from behalf of the Company through inLOBBY.com.

### **3. Description of Services**

- 3.1. Upon the request of the Client Company provides the Client with a personal account.
- 3.2. The Client makes reservation by its own bank card through inLOBBY.com, following which the Company provides the Client a confirmation to the relevant booking done on behalf of the Client.
- 3.3. In case of each booking, done by the Client, a commission in the rate of 3 (three) % from the total amount of booking is accumulated in the personal account of the Client in inLOBBY.com.
- 3.4. In case of reservation, done by third parties due to the mediation of the Client, a commission in the rate of 3 (three) % from the total booking amount is accumulated to the commission amount of the Client upon the condition the Company is informed about the relevant reservation by a written notice sent to info@inlobby.com e-mail address.
- 3.5. Total amount of commission, accumulated in the personal account of the Client in inLOBBY.com, can be used by the Client while making another reservation through inLOBBY.com.

### **4. Legal Relations of the Parties**

- 4.1. The Company guarantees the functionality of inLOBBY.com for providing Information of the Hotels through inLOBBY.com.
- 4.2. The Company is obliged in case of sufficient for reservation amount of commission to make a booking at the expense of commission amount, in accordance with a suchlike request from the Client.
- 4.3. While making a booking through inLOBBY.com, the Client is obliged to get acquainted with the Hotel cancellation, amendment and booking policies.

4.4. The Parties agree that the Company acts only as an intermediate between the Hotels and guests and is not responsible for any failures in the services, provided by the Hotels.

## **5. Term and Termination of the Agreement**

5.1. The present Agreement enters into force upon its signature and is valid for an indefinite period of time.

5.2. The performance of the present Agreement can be terminated immediately by either Party by giving a written notice to the other Party at least 2 (two) months prior to the termination of the Agreement or by mutual consent of the Parties.

5.3. In the event of termination of the present Agreement the total commission amount of the Client shall remain in the personal account of the Client in inLOBBY.com.

## **6. Miscellaneous**

6.1. The dispute of any nature whatsoever arises in connection with, or arising out of, shall be resolved by means of negotiations. In case of disagreement, the resolution of disputes is performed in a manner that is prescribed by Law.

6.2. In the event the Party changes its address name, contact and bank information it shall notify the other Party about suchlike changes within 5 (five) working days.

6.3. This Agreement is made in the English language and consists of 2 pages.
